• Eligibility For Submission Of Bids

1. The Bidder may be a company, limited liability partnership (LLP), partnership firm validly incorporated and/or registered under the laws of India, or a sole proprietorship or individual and is competent to Contract.
2. A bidder (including any proposed subcontractor of a bidder) if affiliated with an entity which has provided consulting services during the preparatory stages of the Works or who has been hired (or is proposed to be hired) as Engineer's Representative for the Contract shall not be eligible to participate in the bidding process.
3. Bidders shall provide evidence of their eligibility to the satisfaction of the Employer.
4. Consortium is not allowed.

• Minimum Qualification of the Bidder

1. The Bidder must be a well established Engineering Contractor having experience in similar scope of works. The bidder should possess and be able to deploy all the machinery/ equipment necessary for the timely completion of the Works and shall augment the same if considered necessary by the Engineer to achieve the targeted progress of the works at no additional cost to the Employer.
2. To get qualified for being considered for award of the Contract, bidders shall provide evidence, satisfactory to the Employer, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:

(a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

Financial Eligibility Criteria

Bidder should have

- i. Achieved in preceding 3 (three) consecutive financial years (ending on 31st March 2020), average annual financial turnover of (of all classes of Electrical Engineering works only) not less than **Rs.11 Crore**.
- ii. liquid assets and/ or credit facilities of not less than **Rs.1.1 Crore** (credit lines/ letter of credit support from bank to be enclosed)
- iii. The profit before tax for any 3 years out of last 5 consecutive financial year should be positive.
- iv. Net worth (NW) for each of the 3 (three) consecutive financial years ending on 31st March 2020 should be more than **Rs.55 Lakh**. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any
- v. Minimum Bid Capacity of **Rs.5.5 Crore**

Technical Eligibility Criteria

- A. The bidder in the preceding three years (up to the date of Bid Notification) should have successfully executed and completed following works:
- RCC works of minimum 5500 CMt. in Civil Works projects, out of which one project should be having minimum 2075 CMt. of RCC quantity.
 - Reinforcement works of minimum 950 MT in Civil Works projects, out of which one project should be having minimum 350 MT of Reinforcement quantity.
- B. The bidder in the preceding three years (up to the date of Bid Notification) should have successfully executed and completed Construction of any one of the below listed works of minimum 0.6 km length in Civil Works projects, out of which one project should be of minimum 0.225 Km length.
- RCC Box structure/trench/tunnel (Minimum Size 2 m x 2 m)
 - RCC retaining walls (minimum height- 4 Mtr)
 - RCC vehicular underpass or bridge
