

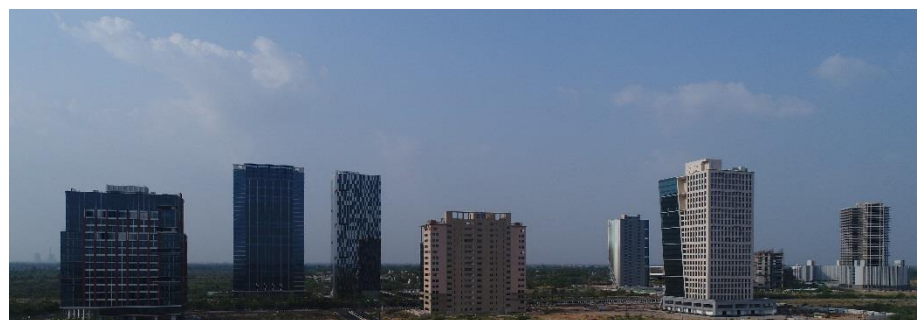
**E-Tender Notice for Invitation to Bid for Selection of Agency for Services on Item Rate Basis**

## • Eligibility For Submission Of Bids

1. The Bidder may be a Company, Partnership firm, Limited Liability Partnership (LLP), Sole Proprietorship firm validly incorporated and/or registered under the laws of India and is competent to contract.
2. Bidders shall provide evidence of their eligibility to the satisfaction of the Client.
3. Consortium is not allowed.

## • Minimum Qualification of the Bidder

1. To get qualified for being considered for award of the Contract, bidders shall provide evidence, satisfactory to the Client, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:

(a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

### Financial Eligibility Criteria

Bidder should have

- i. Achieved in previous consecutive three (3) financial years, average annual financial turnover not less than **Rs.80 lakh** per year as on 31<sup>st</sup> March 2020 from similar type of service income only .
- ii. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any (as derived from audited balance sheets) for the preceding 3 (three) consecutive financial years as on 31<sup>st</sup> March 2020 should be more than **Rs.4 lakhs**
- iii. The profit before tax for any 3 years out of last 5 consecutive financial year should be positive

### Technical Eligibility Criteria

The bidder shall have successfully completed following services and minimum quantities of work in last three consecutive years as on date of inviting tender:

1. The Agency shall have carried out Road cleaning, Paved area cleaning, and Cleaning services for any Plant building/Office establishment/Utility tunnel / other areas / premises (Government/Private) with supply of minimum 34 (Thirty Four) numbers of manpower per day for the period of min. one year duration, out of which one service contract shall have completed with supply of minimum 15 (Fifteen) numbers of manpower for one year duration.

And;

2. The service provider shall own min. 2 nos of Mechanical Sweeping Machine of equivalent or better specifications as mentioned in the Tender Document
