

Minimum Qualification of the Bidder

Financial Eligibility Criteria:

Bidder Should have:

- i. Achieved in previous consecutive three (3) financial years, average annual financial turnover not less than Rs. 4.53 Crore per year as on March 2018 from similar nature of services income only . (Refer Tech-7).
- ii. Net worth (NW) = Share Capital + Reserves and Surplus Miscellaneous Expenditure Revaluation Reserves, if any (as derived from audited balance sheets) for the preceding 3 (three) consecutive financial years as on March 2018 should be more than Rs. 20 lakhs (Refer Tech-7)).

Technical Eligibility Criteria:

The agency should have successfully executed and completed following services in last five years (as on date of inviting tender):

The Agency must have executed, developed and maintained Horticulture & Landscape works for Government-Semi Govt. Organizations/ Public Sector/ Institutions for minimum 50 Acres of area and had supplied minimum 250 nos of Manpower in maximum of 3 projects out of which supplied min. 90 nos. manpower in any one project of similar nature
