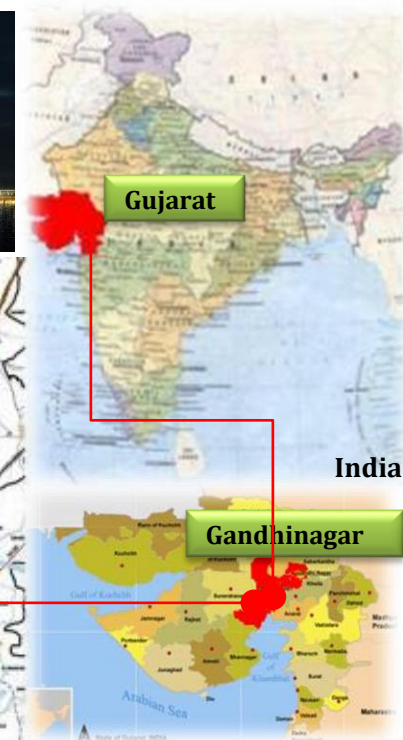


**E-Tender Notice for Invitation to Bid for Selection of Contractor for Works on Item Rate Basis**

## • Eligibility For Submission Of Bids

1. The Bidder may be a company, partnership firm, limited liability partnership (LLP), sole proprietorship firm or any other legal entity validly incorporated and/or registered under the laws of India, and is competent to Contract.
2. A bidder (including any proposed subcontractor of a bidder) if affiliated with an entity which has provided consulting services during the preparatory stages of the Works or who has been hired (or is proposed to be hired) as Engineer's Representative for the Contract shall not be eligible to participate in the bidding process.
3. Bidders shall provide evidence of their eligibility to the satisfaction of the Employer.
4. Consortium is not allowed.

## • Minimum Qualification of the Bidder

1. To get qualified for being considered for award of the Contract, bidders shall provide evidence, satisfactory to the Employer, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:

(a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

### **Financial Eligibility Criteria**

Bidder should have

- i. Achieved in preceding 3 (three) consecutive financial years, average annual financial turnover of (of all classes of Supply and engineering works only) not less than Rs.1.8Cr (Refer Format 10 in Section 5 of the bidding document)..
- ii. liquid assets and/ or credit facilities of not less than Rs.16 Lakhs (credit lines/ letter of credit support from bank to be enclosed) (Refer Format 2 in Section 5 of the bidding document))
- iii. The cumulative profit before tax for last 3 consecutive financial years should be positive.
- iv. Net worth (NW) for each of the 3 (three) consecutive financial years ending on 31st March 2017 should be more than Rs.8 Lakh. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any (Refer Format 2 in Section 5 of the bidding document)
- v. Minimum Bid Capacity of Rs.80 Lakhs (Refer Format 4 in Section 5 of the bidding document)

### **Technical Eligibility Criteria (Bidder shall submit the following technical information documents along with technical Bid)**

The Bidder should have executed in last five years (as on date of inviting tender), the following minimum quantities of work

Executed & Successfully completed construction of road work or misc. road related works (Repair and renovation works, road marking works) amounting to 1.6 Crores in maximum 3 completed projects out of which minimum one project of similar nature of not less than Rs.60 lakhs.

By interested bidders during the dates of online downloading of bidding documents and Bids will be submitted on or before the last date and time for submission of bids as mentioned in the Abstract of the bid document
3. Bidders have to submit Financial Bid [Volume-2 (Section 6)] in electronic format only on <https://gift.nprocure.com> website on or before the last date & time for online submission. Offers in physical form shall not be accepted in any case.
4. The Bidder should submit the Technical Bid including Tender Fee, Bid Security, Bid & related documents etc. [Volume-1 (Section 1 to 9)] in physical form at the office of GIFT CL, GIFT City, Gandhinagar, so as to reach on or before last date and time of physical submission of technical bids, as mentioned in the Abstract of the bid document. GIFT CL shall not be responsible for any kind of postal delay.
5. Bids shall not be received, entertained, accepted after the stipulated date and time.

The interested bidders, who wish to participate in E-tendering, will have to be registered on <https://gift.nprocure.com> and will have a valid Digital Certificate as per Information Technology Act, 2000, using which they can sign, submit their bids electronically.
