## • Eligibility For Submission Of Bids

1. The Bidder may be a Company, Partnership firm, Limited Liability Partnership (LLP), Sole Proprietorship firm validly incorporated and/or registered under the laws of India and is competent to contract.
2. The bidder shall be an authorized service provider of OEM.
3. The authorized service provider shall provide Manufacture authorization form (MAF) of OEM, in absence of MAF their bid will be rejected. And before the award of contract, the preferred bidder will also provide letter of support from the OEM for the period mentioned in the tender.
4. Bidders shall provide evidence of their eligibility to the satisfaction of the Client.
5. Consortium is not allowed.

## • Minimum Qualification of the Bidder

1. To get qualified for being considered for award of the Contract, bidders shall provide evidence, satisfactory to the Client, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:

(a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

### **Financial Eligibility Criteria**

Bidder should have

- i. Achieved in previous consecutive three (3) financial years, average annual financial turnover not less than **Rs.20 lakh** per year as on March 2019 from similar type of service income only .
- ii. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any (as derived from audited balance sheets) for the preceding 3 (three) consecutive financial years as on March 2019 should be more than **Rs.1 lakhs**

### **Technical Eligibility Criteria**

The bidder in the preceding three years (up to the date of Bid Notification) should have successfully supplied, implemented and managed the Checkpoint Sandblasting Solution in at least 2 Organizations.
