

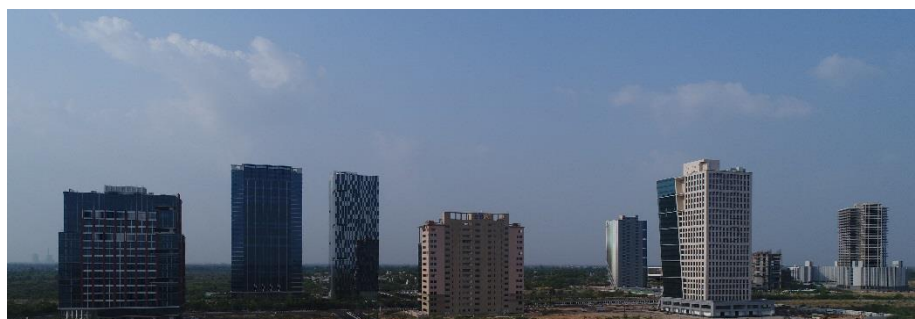
E-Tender Notice for Invitation to Bid for Selection of Contractor for Works on Item Rate Basis

• Eligibility For Submission Of Bids

1. Bidder may be a national or international company, partnership firm, limited liability partnership (LLP), sole proprietorship firm /an individual validly incorporated and/or existing under the laws of India and is competent to Contract.
2. In case of International Company, the Company should be registered and operating in India in similar projects for last 3 preceding financial years. In case of technology-based projects, the condition of operations in India may not be required
3. A bidder (including any proposed sub-consultant of a bidder) if affiliated with an entity which has provided consulting services during the preparatory stages of the Works or who has been hired (or is proposed to be hired) as Engineer's Representative for the Contract shall not be eligible to participate in the bidding process.
4. Bidders shall provide evidence of their eligibility to the satisfaction of the Employer/Client.
5. The bidder shall not be allowed to form the consortium nor to appoint any sub consultant.

• Minimum Qualification of the Bidder

1. The entities or its associates/affiliates directly or indirectly engaged by the Client, for any services which relate to the Assignment under this RFP or any part thereof, are not allowed for submission of bid/ proposal.
2. To get qualified for being considered for the Contract, the Bidders shall provide evidence, satisfactory to the Client, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:
 - (a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

Financial Eligibility Criteria

Bidder should have

- i. Achieved in preceding 3 (three) consecutive financial years, average annual financial turnover not less than **Rs.3.25 Crore** per year as on 31st March 2020 from similar type of supply & service income.
- ii. liquid assets and/ or credit facilities of not less than **Rs.32.60 Lakh** (credit lines/ letter of credit support from bank to be enclosed)
- iii. The profit before tax for any 3 years out of last 5 consecutive financial year should be positive.
- iv. Net worth (NW) for each of the 3 (three) consecutive financial years ending on 31st March 2020 should be more than **Rs.16.35 Lakh**. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any
- v. Minimum Bid Capacity of **Rs.1.63 Crore**.

Technical Eligibility Criteria

- i. Bidder shall have experience of Development of SCADA system for any 02 system out of following systems in two projects, in last 05 years:
 - a. Power substation of 66KV and above
 - b. Water treatment plant and water distribution network
 - c. Sewage network plant
 - d. Automatic waste collection plant and collection network
 - e. Chilling plant system
- ii. Bidder shall have experience of integrating multiple utilities in any control room for operation and control, in last 05 years
