**PUBLIC NOTICE**

1. GIFT Power Company Limited (hereafter referred to as "GIFTPCL") has filed its petition before Hon'ble GERC vide Case No. 2037/2021 for 'True up of FY 2020-21 and Determination of ARR & Tariff for FY 2022-23'.
2. Pursuant to GERC (Multi Year Tariff) Regulation 2016 and Suo-Moto Order dated 24.09.2021, it is hereby notified that the persons who are interested in filing their objections/suggestions to the above Petition, may file the same with The Secretary, Gujarat Electricity Regulatory Commission (GERC) 6<sup>th</sup> Floor, GIFT ONE, Road 5-C, Zone 5, GIFT City, Gandhinagar- 382355, on or before 10/01/2022 with the documents on which they want to rely upon in five sets, duly supported by an affidavit and also indicate whether they want to be heard in person. One copy of such submission is required to be sent at the below mentioned address of registered office of GIFT Power Company Limited within 30 days of this notification.
3. For reference those who are interested, copy of the Petition is available for inspection at the office of GIFT Power Company Limited, EPS - Building no. 49A, Block 49, Zone 04, Gyan Marg, GIFT City, Gandhinagar – 382355.
4. GIFTPCL has proposed rationalization of tariff and the proposed tariff will be effective from 1<sup>st</sup> April 2022. The proposed Tariff Schedule for FY 2022-23 is given below.

**Notes:**

- (i) **Billing Demand** shall be the highest of the following:
  - (a) Actual maximum demand established during the month
  - (b) Eighty-five percent of the contract demand
  - (c) One hundred kVA (HTP-I and HTP II)
- (ii) **Reactive Energy Charges (applicable for LTMD Category Only)** : 10 paise per KVARH for all the reactive units (KVARH) drawn during the month
- (iii) **Time of Use Charges** (For energy consumption during the two peak periods, viz., 0700 Hrs. to 1100 Hrs. and 1800 Hrs. to 2200 Hrs)
  - For HTP - I and HTP –II categories - **For Billing Demand up to 500 kVA: 45 Paise per Unit; For Billing Demand above 500 kVA: 85 Paise per Unit**
  - For HTP – III Category: 85 Paise per Unit
- (iv) **POWER FACTOR ADJUSTMENT CHARGES (applicable for all HT Categories):**  
**Penalty for Poor Power Factor:**
  - (a) The power factor adjustment charges shall be levied at the rate of 1% on the total amount of electricity bills for the month under the head “Energy Charges”, arrived at using tariff as per respective categories, for every 1% drop or part thereof in the average power factor during the month below 90% up to 85%.

- (b) In addition to the above clause, for every 1% drop or part thereof in average power factor during the month below 85% at the rate of 2% on the total amount of electricity bill for that month under the head “Energy Charges”, arrived at using tariff as per respective categories, will be charged.

**Power Factor Rebate:**

If the power factor of the consumer’s installation in any month is above 95%, the consumer will be entitled to a rebate at the rate of 0.5% (half percent) in excess of 95% power factor on the total amount of electricity bill for that month under the head “Energy Charges”, arrived at using tariff as per respective categories, for every 1% rise or part thereof in the average power factor during the month above 95%.

- (v) **Rebate For Supply at EHV (applicable for HTP-I and HTP-II Categories) :** On Energy Charges  
(a) If Supply is availed at 33/66 kV – Rebate @ 0.75%  
(b) If Supply is availed at 132 kV and above – Rebate @ 1.25%
- (vi) **Concession For Use of Electricity During Night Hours (applicable for HTP-I Category only):**  
The energy consumed during night hours of 10.00 PM to 06.00 AM next morning shall be eligible for concession at the rate of 43 Paise per unit.

5. GIFT PCL proposed base FPPPA as Rs 2.00 per kWh and requested for subsequent modification as per corresponding change in FPPPA of UGVCL in future.
6. **Submission of Response:** In accordance with GERC ( Conduct of Business) Regulations 2004, it is hereby notified that the persons who are interested in filing their objections/suggestions on the above subject matter petition, may file the same with the Secretary, Gujarat Electricity Regulatory Commission, 6th floor, GIFT One, Road 5C, Zone 5, GIFT City, Gandhinagar – 382 355 along with the document on which they want to rely upon, in five sets, duly supported by an affidavit with the copy to the undersigned on or before 10/01/2022 and also indicate whether they intend to be heard in person.
7. Further, the copy of Petition will be available for sale at **Rs. 150/- (Rs. One Hundred and Fifty Only)** at the GIFT PCL office address. For obtaining the copy of the Petition by post, postage fee of Rs. 50/- (Rupees Fifty Only) will be payable extra. The total amount in such case to be sent by Demand Draft payable in favour of GIFT Power Company Limited on the said address.
