## • Eligibility For Submission Of Bids

1. The Bidder may be a company, partnership firm, limited liability partnership (LLP), sole proprietorship firm or any other legal entity validly incorporated and/or registered under the laws of India and is competent to Contract.
2. The Bidder would have to submit their PF and GST registration certificate along with Technical bid, in absence of which their bid will be treated nonresponsive.
3. Bidders shall provide evidence of their eligibility to the satisfaction of the Employer.
4. The bidder shall not be allowed to form the consortium nor to appoint any sub-Contractor.

## • Minimum Qualification of the Bidder

1. The Bidder must be a well established Manufacturer, having experience in supply of Precast retaining wall. The bidder should possess all the resources for the timely supply of the Goods. The bidder should possess and be able to deploy all the machinery/ equipment necessary for the timely completion of the Supply and shall augment the same if considered necessary by the Engineer to achieve the targeted progress of the Supply at no additional cost to the Employer.
2. To get qualified for being considered for award of the Contract, bidders shall provide evidence, satisfactory to the Purchaser, of their capability and adequacy of resources to carry out and execute the Contract effectively. All bidders shall include the following information and documents with their bids:

(a) Bidders should meet the following minimum qualification cum eligibility criteria on a pass or fail basis:

### I. Financial Eligibility Criteria

Bidder should have

- i. Achieved in preceding 3 (three) consecutive financial years as on 31<sup>st</sup> March 2022, average annual financial turnover of (of all classes of supply of similar type of products only) not less than **Rs. 182 Lakhs**.
- ii. The profit before tax for any 3 years out of last 5 consecutive financial year should be positive.
- iii. Net worth (NW) for each of the 3 (three) consecutive financial years ending on 31<sup>st</sup> March 2022 should be more than **Rs. 9.10 Lakhs**. Net worth (NW) = Share Capital + Reserves and Surplus – Miscellaneous Expenditure – Revaluation Reserves, if any.

### II. Technical Eligibility Criteria (Bidder shall submit the following technical information documents along with technical Bid)

The bidder in the preceding three years (up to the date of Bid Notification) should have successfully supplied Precast Earth Retaining walls, 1000mm height and 850mm toe, of minimum 3500 m length and should have successfully supplied at least 1 order of minimum 1300 m Retaining Wall supply.

AND

The bidder should have valid legal registration in India for manufacturing factory made precast products. The bidder should be certified for ISO 9001, ISO 14001 and ISO 45001 for design, manufacture, and dispatch of products. The bidder should be primary manufacturer of the precast units including structural designing, as per load conditions at site. Precast manufacturer should submit the design calculation report of each product with calculation details considering lifting loads. The precast factory should have in house QA-QC set up to ensure consistent quality of precast products.
